This document serves as our spay/neuter contract and will be signed when purchasing a puppy as "pet" only with limited AKC registration. This agreement is legal and binding. If purchasing a puppy as "pet" only you will be required to have your puppy spayed/neutered between eighteen (18) and twenty-four (24) months old. Permanent ownership of this puppy is contingent upon my compliance with this contract. Failure to spay/neuter your puppy within two (2) months after the puppy turns twenty-four (24) months old will result in a fine of \$1,500 to be paid to the **BREEDER** and the puppy will be returned to the **BREEDER** and no refund will be provided. In the event that the puppy's health does not allow this agreement to be honored, the **BREEDER** must be provided with a statement from your veterinarian that this puppy is not yet in physical condition for surgery. Based upon the veterinarian's evaluation of this puppy, the **BUYER** will continue to have the puppy reevaluated every six (6) months until the veterinarian feels the puppy can be spay/neutered safely and make an appointment accordingly. The **BUYER** will notify the **BREEDER** of this amendment in writing, at which time all other conditions of this agreement will apply and continue to be enforced. It is the responsibility of the **BUYER**, not the **VETERINARIAN**, to ensure that the **BREEDER** receives verification that the surgery has been performed. Failure to comply with this agreement by the date listed below, unless otherwise agreed to in writing, will be considered a breach of the contract and the **BUYER** will be responsible for transporting this puppy back to the **BREEDER**, including any and all shipping costs. If the **BUYER** is considered to be in breach of the contract no refund will be provided for the purchase of this puppy or shipping costs. The **BUYER** will be responsible for all costs associated with the return of the dog including, but not limited to, transportation fees, any training or veterinary care the puppy may need, any costs associated with retraining the puppy due to behavioral issues that may make placing the puppy in a new home difficult, and any fees related to changing the puppy's AKC registration. If a breeding should occur, whether it be on purpose or accidental, the **BUYER** will have to pay a fine of \$4,500 per puppy (dead or alive) to the **BREEDER** and is required to return the original puppy and any puppies that were produced. Any breeding would mean the **BUYER** forfeits the right to own the puppy and any puppies produced would be unregistrable.

The **BUYER** understands that permanent ownership of this puppy is contingent upon my compliance with this contract. Proof of the spay/neuter for your puppy must be received within fourteen (14) days after the surgery. If the **BUYER** fails to spay/neuter the puppy within two (2) months of the puppy turning twenty-four (24) months of age, or the date listed below, the **BUYER** will be considered to be in breach of this contract and will be charged a fine of \$1,500 to be paid to the **BREEDER** and the puppy must be returned to the **BREEDER**.

The **BUYER** understands that in the event that the puppy's health does not allow this agreement to be honored, the **BREEDER** must be provided with a statement from your veterinarian that this puppy is not yet in physical condition for surgery. The **BUYER** will continue to have the puppy reevaluated every six (6) months until the veterinarian feels the puppy can be spay/neutered safely and make an appointment accordingly. The **BUYER** will notify the **BREEDER** of this amendment in writing, at which time all other conditions of this agreement will apply and continue to be enforced.

I also agree that should the puppy not be altered by the above date, that I will return said puppy back to the **BREEDER** and that I am responsible for any shipping/transportation costs. I understand that I will not receive a refund.
